

Tariff and Cost Regulations KINTO Share

Prices valid from 30.01.2023

All prices in euros including statutory value-added tax. The travel costs are calculated from the respective time tariff (minute, hourly, daily or weekend tariff) and the kilometer price, including fuel (such as gasoline, electricity for e-cars, hydrogen). In the trip free distance received is 20.0 kilometers. If the minute or hourly rate exceeds the daily rate within a day, the daily rate will be charged.

The proof and assertion of further damages by KINTO remains unaffected by this; a forfeited contractual penalty will be credited in this case.
